## SECTION 5: Fire-fighting measures

### Extinguishing media:

**Suitable:** NFPA Class III B (Combustible liquid): Use water spray, ABC dry chemical, foam or carbon dioxide. Water or foam may cause frothing. Use water to keep fire-exposed containers cool. Water spray may be used to flush spills away from exposures.
